Focus of Release: The areas of focus for the 21.10 release include enhancements to the Certificate of Eligibility (COE) pertaining to Interest Rate Reduction Refinance Loan (IRRRL) funding fee exempt status, automation of the Reserve National Guard (RNG) eligibility determination for COE, and creation of new fields to update the User Interface (UI). Additionally, enhancements were added to the creation of loans in the Administrative Loan Accounting Center (ALAC) and document additions to VALERI. The value added through these changes increases the capabilities of the LGY Suite program participant to provide more accurate and prompter service to Veterans.
